## **Clay County Transportation**

Is a consolidated public transportation system funded by federal, state and local governments as well as fare revenue collected by the system.

The fare for the General Public is 10% of the cost of the trip. Fares are based on destination. We are not a taxi-cab service, all trips are booked in advance on a first-come, first- served basis. We ask for two days notice to book your trip. We operate from 7am-5pm Monday-Friday.

CCT provides local trips and long distance medical trips to Asheville, Atlanta and Chattanooga. We ask that you schedule your appointment time between 10am-2pm for long– distance medical trips.

CCT has a Number of vans that are equipped with wheelchair lifts. An attendant or relative is welcome to ride with you if you need assistance.



Service animals are also welcome.

# **Rider Information:**

- Seatbelts must be worn at all times
- No smoking, eating or drinking is allowed on the vans.
- We are a transportation service only. We cannot provide personal assistance such as dressing of lifting passengers out of bed or wheelchairs.
- A 15 minute service window is allowed for passenger trips. This means the van may pick you up 15 minutes earlier or later than your scheduled pick up time.

# Medical Trips: Need a ride to the doctor?

Medical transportation is the heart of what we do. CCT provided local trips, and travels as far as Asheville and Chattanooga to get you to the care you need.

# **Employment Trips:**

#### Need a ride to work?

CCT will get you to and from your job, within



Clay County for a low fare of \$1 per boarding. At this time, we can only travel out of county of we can fit your trip in with one of our regular scheduled routes.

### **Government Complex Trips:** *Need a ride to a county office?*

CCT will take you where you need to go: the post office, DSS, the Courthouse, etc. for only \$1 per boarding.

#### Need a ride to the store?

CCT will take you to local stores, for only \$1 per boarding. CCT offers a scheduled trip to Murphy each Tuesday for \$5 per round

trip. A fun group shopping trip is scheduled on the second Friday of each month.
